

ORDINANCE NO. 2013-10-03

EARTH CHANGE AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND ARTICLE III, SECTION 3 OF THE EARTH CHANGE ORDINANCE ADOPTED BY ROBINSON TOWNSHIP, OTTAWA COUNTY, MICHIGAN, SPECIFICALLY BY ADDRESSING THE CLASSIFICATION OF EARTH CHANGE PERMITS AND BY PROVIDING FOR THE EFFECTIVE DATE OF THIS ORDINANCE.


ROBINSON TOWNSHIP, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:


Section 1. Classification of Permits. Article III, Section 3 of the Earth Change Ordinance is restated in its entirety as follows:

Section 3. Classification of Permits. Permits required pursuant to this Ordinance for an Earth Change within the Township shall be classified as follows.

- (a) Class A Permits. A "Class A Permit" shall, for purposes of this Ordinance, mean a permit to allow an Earth Change when the volume of the Earth Change does not exceed 5,000 cubic yards.
- (b) Class B Permits. A "Class B Permit" shall, for purposes of this Ordinance, mean a permit to allow an Earth Change when the volume of the Earth Change exceeds 5,000 cubic yards.

Section 2. Effective Date. This Ordinance was approved and adopted by the Township Board of the Township of Robinson, Ottawa County, Michigan, on October 9, 2013, and it is ordered to take effect 30 days after publication in the *Grand Haven Tribune*, a newspaper of general circulation in the Township of Robinson, pursuant to the provisions of Act 246 of the Michigan Public Acts of 1945, as amended.


