Commissioner Greg DeJong gave updates on happenings in the County including an update on the M231 race, a park report, the upcoming Diversity Forum, water quality forum and a meeting in Allendale about proposed dredging of the Grand River.

Public comment: Lee Fisher, the current Assistant Chief Prosecutor, who is running for Ottawa County Prosecutor introduced himself to the Board and audience.

Vugteveen made a motion supported by Berens to approve Ordinance No. 2019-11-06 an ordinance to amend certain portions of the zoning map for the purpose of rezoning certain property to the RR Rural Residential zoning district based on the Planning Commission's recommendation. Roll call vote was held with all members present voting yes. Motion carried.

Saddler made a motion supported by Berens to approve the Contract Zoning Agreement, draft date 10/24/19, between Robinson Township and; Linda Slagel, Denice and Adam Fett, Patricia and David Schmoekel, Angela and Ryan Schmoekel, Amy and Derek VanGalder and Susan and Gregory Borta. Roll call vote was held with all members present voting yes. Motion carried.

Berens made a motion supported by Saddler to approve the monitoring contract with EPS for the new office security door. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Hayward to approve Resolution No. 2019-11-19: Cemetery Fee Schedule, effective November 13, 2019. Roll call vote was held with all members voting yes. Motion carried.

Berens made a motion supported by Vugteveen to approve Resolution No. 2019-11-20: Road Maintenance Millage Renewal, placing a proposal on the March 10, 2019 ballot to request a renewal of the previous road maintenance millage at the current, headlee adjusted, rollback rate. Roll call vote was held with all members present voting yes. Motion carried.

Information was received from the Ottawa County Road Commission on costs for next year's road resurfacing projects. This will be looked at further at budget time.

Hayward made a motion supported by Vugteveen to approve *Resolution No. 2019-11-21: MTTP Grant Application for Backup Cameras*. Roll call vote was held with all members present voting yes. Motion carried.

Information was received from Michigan Chloride Sales regarding the fees for 2020 road brining.



Kuck made a motion supported by Hayward to table the discussion on a water filtering system for the Township Hall. Motion carried.

Discussion was held regarding the County's Groundwater Initiative and having a joint meeting with the PC to discuss.

Discussion was held regarding allowing the Loutit Library to scan historical records from the vault. Attorney Bultje advised that temporary removal of records from the vault is allowed provided that a chain of custody is maintained so that it is known; what has been removed, when it will be returned and who is responsible for it.

Saddler made a motion supported by Hayward to untable the Tejchma Class A Earth Change Permit. Motion carried.

Vugteveen made a motion supported by Hayward to approve the Class A Earth Change for 70-08-18-200-039 for Paul and Linda Tejchma on Paul Lin lane based on the recommendations and conditions set forth at the Planning Commission meeting held 09/24/19 with the further condition that any escrow deficit be paid in full. Roll call vote was held with all members present voting yes. Motion carried.

Kuck made a motion supported by Berens to untable the discussion on escrow and permit fees. Motion carried.

Berens made a motion to approve the discussed revised fees for applications. No support was given to the motion. Motion died on the table.

Hayward made a motion supported by Berens to table the discussion on escrow and permit fees. Motion carried.
