

Minutes of the Regular Meeting  
Robinson Township Board of Trustees  
October 13, 2021 at 7:00 pm

Present: Supervisor Frank Johnson, Treasurer Bonnie Hayward, Clerk Christine Saddler, Trustee Travis Vugteveen and Trustee Travis Bergman

Absent: None

Also present: Attorney Ron Bultje and ten members of the public

The meeting was opened at 7:02 pm

The Pledge of Allegiance was recited. Supervisor Johnson gave the invocation.

Vugteveen made a motion supported by Bergman to approve the minutes from the September 08, 2021 meeting. Motion carried.

Johnson made a motion supported by Vugteveen to approve the agenda switching the order to place renewal of insurance to number one and Dollar General to number three. Motion carried.

Supervisor Johnson gave his opening remarks

Ottawa County Commissioner Greg DeJong was absent.

Megan Roschek from Burnham and Flower Insurance reviewed the insurance renewal proposal.

Bergman made a motion supported by Saddler to approve the renewal of insurance with the increase in deductibles for the trailers and fire vehicles from \$500 to \$1,000, keeping everything else the same. Roll call vote was held with all members present voting yes. Motion carried.

Supervisor Johnson opened the Public Hearing for the special use application for Fox and Hen Winery. Owner Wil Malski answered questions regarding the project. There were no comments for or against the project.

Vugteveen made a motion supported by Hayward to close the Public Hearing. Motion carried.

Vugteveen made a motion supported by Hayward to approve the Site Plan and Special Use permit under the roadside stand/agricultural structure requirements for parcel no. 70-08-11-200-031 based on the findings and requirements set forth by the planning commission at the August 24, 2021 meeting. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Bergman to approve the Midwest V, LLV (Dollar General) site plan modification for parcel 70-08-27-100-010 to include the two signs as stated in the application dated 8/3/2021 based on the recommendation and requirements set forth by Planning Commission at the

September 14, 2021 meeting. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Bergman to approve the fabrication and installation of two "TRUCKING RESTRICTED BY ROBINSON TOWNSHIP ORDINANCE" signs for 104<sup>th</sup> Ave and 136<sup>th</sup> Ave for the new paving projects at a cost of \$417.94. Roll call vote was held with all members present voting yes. Motion carried.

Hayward made a motion supported by Johnson to approve the quote from Diemer's Property Services LLC for mole patrol services for 1 year at a cost of \$1,710.00 which will cover the Township Office and Township Park. Roll call vote was held with all members present voting yes. Motion carried.

Hayward made a motion supported by Bergman to table the discussion on additional excavating and hydro seeding near the new basketball court. Motion carried.

Vugteveen made a motion supported by Johnson to table the discussion regarding the quote received from Diemer's for tree trimming. Motion carried.

It was the consensus of the Board to have Attorney Bultje draft a contract for the Board to review. This contract would provide the means to allow a resident whose house burned down and is experiencing delays in rebuilding to temporarily live in a trailer on their property while setting restrictions.

Public comment: none

Hayward made a motion supported by Bergman to pay the bills. Motion carried.

Reports were given on NORA, Fire Department, Ambulance Oversight and Treasurer.

Treasurer Hayward suggested exploring the idea of having different food trucks come to the Park during the busy nights next summer. This idea will be shared with the Park Board.

Fire Department will be participating in a Trunk or Treat at the Robinson Elementary School on Friday, October 22<sup>nd</sup>.

Motion was made by Vugteveen and supported by Bergman to adjourn the meeting at 8:49 pm. Motion carried.
