

Minutes of the Regular Meeting
Robinson Township Board of Trustees
May 11, 2022 at 7:00 pm
12010 - 120th Ave, Grand Haven MI 49417

Present: Supervisor Frank Johnson, Treasurer Bonnie Hayward, Clerk Christine Saddler, Trustee Travis Vugteveen and Trustee Travis Bergman

Absent: None

Also present: Attorney Ron Bultje and twelve members of the public.

The meeting was opened at 7:00 p.m.

The Pledge of Allegiance was recited. Supervisor Johnson gave the invocation.

Vugteveen made a motion supported by Johnson to approve the revised minutes from the March 30, 2022 meeting. Motion carried.

Hayward made a motion supported by Saddler to approve the minutes from the April 13, 2022 Regular Board Meeting. Motion carried.

Vugteveen made a motion supported by Johnson to approve the agenda with additions of MME Class B Earth Change Cell change, Use of Park for Library Summer program, Voter ID Card Printing. Motion carried.

Supervisor Johnson gave his opening remarks.

County Commissioners Greg DeJong and Phil Kuyers gave an update on happenings at the County level. Because of redistricting Phil Kuyers will be the Commissioner for all of Robinson Township.

Johnson made a motion supported by Hayward to approve Resolution NO. 2022-05-10 Bethke Drain Authorization to Exceed which will allow the Ottawa County Water Resources Commissioner to exceed the allowed \$5,00 per mile. The cost for the maintenance shall not exceed \$19,000. Roll call vote was held with all members present voting yes. Motion carried.

Saddler made a motion supported by Johnson to approve Fire Fund Budget Resolution 2022-05-11. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Hayward to approve the quote from Addorio Technologies LLC for a new server at a cost of \$11,017.83, which had been previously budgeted. Roll call vote was held with all members present voting yes. Motion carried.

Hayward made a motion supported by Saddler to approve the quote from Diemer's Property Services LLC for stump grinding the oak tree at the Township Hall at a cost of \$680. Roll call vote was held with all members present voting yes. Motion carried.

Vugteveen made a motion supported by Johnson to approve the contract with Tri-Cities Youth Soccer Organization (TYSO) for use of the Township Park given that a request is to be made to have the Township added as an additional insured and to authorize the Clerk and Supervisor to execute the agreement. Roll call vote was held with all members present voting yes. Motion carried.

Hayward made a motion supported by Bergman to approve the cell change for the Class B Earth Change Permit for MME, moving cell 4 to and interim status and cell 6 to open status. Motion carried.

Saddler made a motion supported by Hayward to approve Loutit Library to use the Township Park for a summer event at no charge with the request that the Township be added as an additional insured. Motion carried.

Vugteveen made a motion supported by Johnson to approve the quote from Printing Systems Inc. for the printing and mailing of new voter information cards at a cost of \$3,228.77. Roll call vote was held with all members present voting yes. Motion carried.

Public comment: discussion was held regarding Spring Meadow Nursery and concerns from residents that there is traffic at the loading docks at all hours. It was recommended that they contact the Ottawa County Sheriff's Deputy assigned to this area.

Motion was made by Vugteveen and supported by Hayward for to give permission for the Zoning Administrator to contact Attorney Bultje as necessary regarding Spring Meadow Nursery. Motion carried.

Hayward made a motion supported by Vugteveen to pay the bills. Motion carried.

Reports were given: NORA may be asking for a millage, May election had approximately a 13% turnout, Fire Department had 24 runs, ambulance report on file, Library minutes received.

Discussion was held regarding brining of the gravel roads. Supervisor Johnson is waiting for a official quote and has tentatively schedule one date for around June 2 or 3rd. This has not been approved by the Board yet and would require a special meeting to be held to have it approved before the brining can be done. The special meeting will be scheduled once Supervisor Johnson receives the quote.

Motion was made by Vugteveen and supported by Johnson to adjourn the meeting at 9:56 pm. Motion carried.
