Hayward made a motion supported by Vugteveen to approve payment to Electromedia for repair to the server for the park security camera. Roll call vote was held with all members present voting yes. Motion carried.

Public Comment: Discussion was held on status of the Sleeper Street paving project and that the message being given to the public does not reflect the facts.
